Real or Virtually Real



of someone trying a Virtual Reality (VR) headset for the first time. They are clawing and swiping at, unseen to the observer, virtual attackers in a virtual world as projected inside their VR headset. It is funny as an outside observer, but if the person experiencing the VR world is moving clumsily and blindly through our real world, that can be dangerous.

It seems that the current political winds have blown away many coal plants in favor of gas-powered generation, wind, solar or other perceived greener alternatives. The pie chart that Nebraska Public Power District has on its wholesale website depicting the day's current generation mix is as follows: 2.2% Oil/gas, 5.9% wind, 0.6% hydro, 0.9% solar, 32.7% nuclear, and 57.7% coal. There is no problem with eliminating carbon emitting generation. It can be replaced by other non or low carbon emitting generation. However, the alternative must be in place BEFORE you remove coal as base load generation.

Currently, nuclear generation is very viable, but not timely, as it takes 5-12 years to construct a new plant from the first cement being poured to the plant generating energy onto the grid. The speed with which the licensing process takes makes a tortoise look supersonic. We continue to wear our VR goggles and pretend that the virtual world we have built our energy policies in is reality, but they are not. The reality is that we are pressured to take coal offline before any real alternatives are available.

We must live in the real world and not a virtual world when it comes to the management of base load generation. We can't march around as if we already have coverage to take the place of carbon-based generation, specifically coal. To ignore the impact of deleting coal strictly for the promotion of the reduction of carbon emissions is not acceptable. The impact will severely reduce reliability. Gas turbines can serve some of the load, but with the policies being enacted to reduce petroleum production, and in turn gas production, we will not have the volume or the pipeline capacity to take up the slack of deleting coal.


There must be actual dispatchable generation to sustain the current and future demand that continues to grow. There has been and continues to be a large build out of wind and solar generation. However, this type



of generation is only available when the wind blows and when the sun shines. The rest of the time you are relying on the dispatchable generation that is available when you need it.

If you were to let the engineers build what we need and give them the resources to do it, they would have solutions in place in short order. We continue to live in a virtual world defined by politics and narratives that promote policies that are not based in the physical world. You can write policy to defy the physics of our real world, but you cannot break the laws of physics. When we have finally shut down too much base load coverage, we will have damaged our ability to provide reliable power in the United States and we will all suffer the consequences.


SWITCH TO PAPERLESS BILLING AND WIN \$50!

AVOID HAZARDS WITH OVERHEAD POWER LINES



School Electrical Safety Program

Every year, North Central Public Power District (NCPPD) provides an Electrical Safety Program for the 4th & 5th graders at the local schools. This year Assistant Operations Manager/Safety Director Tim Hoffman and Energy Advisor Linda Sokol went to St. Ludger's, Creighton Elementary, Verdigre Elementary, Summerland Elementary and Niobrara Elementary. *The Shocking Truth* video was shown followed by a discussion on the dangers of electricity. Students were shown the equipment that the lineman use for safety and even got the chance to see and feel sand that was turned into glass by a live wire. NCPPD uses an energized farm display

to show what could happen if contact is made with an energized power line while flying a kite, climbing a tree, or working with large farm equipment. With the energized farm set, a simulation with a hotdog shows what could happen if someone or something came in contact with an energized power line. It is a real eye opener for the kids when an electrical arc is created using the hotdog as part of the electrical circuit. Hopefully, what the kids learn in this safety program stays with them so if they are ever in a situation where electrical wires are present, they will remember what to or not to do. The students are then given the opportunity to enter a poster into an electrical safety poster contest. Posters will be judged and the winners will receive a \$25 check and be invited to a NCPPD Board of Directors meeting.

Garlic Cheddar Chicken Bake

Ingredients

- 2 Tbsp butter, melted
- ½ cup plain panko bread crumbs
- 1 pkg chicken tenders (not breaded), cut into bite-size pieces
- 1 cup uncooked regular longgrain white rice
- 1 tsp salt
- ¼ tsp pepper
- ¼ tsp garlic powder
- 2 ½ cups chicken broth
- 2 cups shredded cheddar cheese
- Chopped fresh Italian (flatleaf) parsley, if desired

Directions

Heat oven to 375°F. Spray 8-inch square (2-quart) baking dish with cooking spray. In small bowl, mix melted butter and bread crumbs until well mixed. Set aside. In baking dish, mix chicken, rice, salt, pepper, garlic powder, chicken broth and 1 ½ cups of the cheese until well mixed. Bake 45 to 50 minutes or until rice is tender and most of the liquid is absorbed. Sprinkle remaining ¹/₂ cup cheese and the bread crumb mixture evenly over rice mixture. Bake about 5 minutes or until crumbs are light golden brown. Sprinkle with chopped parsley.

Summer Rates Start June 1st

The summer electric rate schedule for North Central Public Power District (NCPPD) will go into effect on June 1, 2023. These rates are effective for the four summer demand months: June, July, August and September. The wholesale, as well as retail, electric rates are higher because Nebraska Public Power District (NPPD) charges NCPPD higher wholesale rates due to its higher costs during this time. It is NCPPD's goal to keep the summer electric peak demand down to prevent or lessen rate increases in the future.

NCPPD encourages customers to reduce their electric usage during these months between the hours of 9 a.m. to 11 p.m. If everyone does their part to reduce usage, hopefully electric rates can continue at an affordable level.
