

Transparency

Over the years, North Central Public Power District (NCPPD) has delivered electricity at 99.9% reliability. This level of reliability has been attainable because of the dedication of those involved. NCPPD's wholesale supplier must maintain transmission and generation to deliver electricity to the district. NCPPD must also maintain its own transmission within the district service area and all the distribution facilities. The distribution includes: the substations that convert transmission voltage to distribution voltage; distribution lines (both single and three phase line); and transformers and meters to deliver electricity to the customer at secondary voltages, which is utilized by the end user. NCPPD's wholesale provider, Nebraska Public Power District (NPPD), has built some of the most diverse and well-maintained generation resources in the United States. Already, NPPD has a 56% carbon-free mix of electricity.

Currently, due to the ever-increasing demand within the state and the wider Southwest Power Pool (SPP), NCPPD's wholesale provider is looking for more generation resources to ensure that there is an adequate supply going forward. In the near term, NPPD must obtain generation and some storage that will fill the demand requirements of the system. This mix could include battery storage, RICE (Reciprocating Internal Combustion Engine), and CT (Combustion Turbine). The placement of these assets would be at current gen-

eration sites. In addition to the added generation, NPPD is looking into the conservation of current generation facilities, whether to obtain a 20-year license extension for Cooper Nuclear Station or what the costs would be for finishing the current license.

As previously written in issues of "North Central's News", NCPPD has had no net rate increases as of the beginning of 2024. For the last several years, operating costs have continued to increase. Future wholesale electricity will become more expensive due to the increased demand and the push for more carbon-free energy.

Whatever NPPD does, it will require

some added costs and investment. As with any public power in Nebraska, the added costs are paid not by the taxpayers, but by the rate payers that benefit from those investments. It is important for NCPPD to carefully monitor these added costs since wholesale electricity is over 67% of the total operating costs.

I think it is important that we are transparent in what we are seeing in the industry. With any decisionmaking process, if you have good information, you can make better decisions. We will continue to share information so that all of us can see the best way forward. I wish you the best in your endeavors.

Doritos[™] Cheesy Chicken Casserole

Ingredients

- 1 bag (10 oz) Doritos™ Cool Ranch™ flavored tortilla chips, coarsely crushed (about 6 cups) ¼ cup butter, melted
- 2 cups shredded Colby-Monterey Jack cheese (8 oz)
- 1 jar (15 oz) four cheese Alfredo pasta sauce
- 1 tablespoon taco seasoning mix (from 1-oz package)
- 3 cups shredded cooked chicken
- 1 can (14.5 oz) fire roasted diced tomatoes, undrained

Directions

Heat oven to 350°F. Spray 13x9inch baking dish with cooking spray. In large bowl, toss Doritos[™] and melted butter until well coated. Sprinkle 4 cups of the Doritos[™] evenly in bottom of casserole. Top with 1/2 cup of the cheese. In large bowl, stir pasta sauce and taco seasoning mix until well blended. Add chicken, tomatoes and ½ cup of the cheese; stir until well mixed. Spoon evenly over Doritos[™] in baking dish. Bake uncovered 30 minutes. Sprinkle with remaining Doritos[™] and remaining 1 cup cheese. Bake about 5 minutes longer or until hot and cheese is melted.
