Participation

As with many things in society today, within the scope of electric utilities, politics impact how electric utilities operate. The laws that exist and are passed set the parameters or environment that utilities must work within.

In Nebraska, most of the electric utilities are public power districts or municipalities. The laws in Nebraska that govern public powers are enabling statutes. Instead of having laws that exclude given activities, there are laws specifically allowing certain activities. Statutes enable public power districts to generate, transmit and distribute electricity. Public power districts can introduce new technologies that may not be available in a rural market initially but once established, private entities are to take over. North Central Public Power District helped introduce DirecTV to rural Nebraska with its involvement in Nebraska Rural TV.

In Nebraska, public power was introduced to provide rural areas with electric services not profitable enough for private companies, but necessary for the public in general.

In the past, I have touched on the advantage you have being served by public power in Nebraska (November/ December issue 2022, "Public Power: Your Unique Advantage"). You can directly participate in your monthly meetings and run for boards that are publicly voted upon. The directors that are elected are from your district and, in most cases, from your local area.

Another place to participate is your state government. Although many people do not have the disposition to be a senator or maybe even the governor of Nebraska, you still have a voice. As a private citizen, you can interact with your Senator who represents you at the Unicameral. With active participation, you can help promote legislation that may be beneficial to your local community, or you can oppose legislation that may be detrimental. Grassroot participation is important with current legislation that can result in impactful laws.

In local papers, there is commentary from your local representatives both on the state and federal level. You may chose to read these updates or go online. There is an official site that you may access to see the status of any given bill or law. A good place to start is https://nebraskalegislature.gov/ bills/intro.php. The site has a place to search bills and laws. It has a link for live video streaming of the legislature when it is in session, a legislative calendar, and a search tool to find your Senator.


There are many opinion editorials and "news" on pending statutes, but be vigilant and do some of your own research to understand everything that is at stake. As a citizen, it is important not to pass on your responsibility to someone else. Participate in the lawmaking process by keeping abreast of the bills in process and letting your representatives know your opinion. Both good and bad opinions of bills help your representative know what the public thinks. You can make a difference; you just need to participate.

City of Plainview Phase 2 Rebuild to Begin

North Central Public Power District (NCPPD) has announced May 1, 2024, as the beginning of **Phase 2** of the City of Plainview electrical system rebuild. **Phase 2**, as shown by the nearby map, indicates in orange the locations where the rebuild will occur.

NCPPD has hired IES, an electrical contracting company from Holdrege, NE, to do the project. IES will be replacing poles and wires. Look for the logo, shown below, on vehicles working in the area. 1. Plant trees in the right place. Trees that will be <40 ft. should be planted at least 25 ft. away from power lines (>40 ft. should be at least 50 ft. away).



2. Don't block pad-mounted transformers. Plant shrubs at least 10 ft. away from transformer doors and 4 ft. from transformer sides.

No-Bake Peanut Butter-Fudge Ice-Cream Pie

Ingredients

3 cups chocolate crisp rice cereal (such as Cocoa Krispies)
½ cup salted dry-roasted peanuts, finely chopped
⅓ cup butter, melted
½ cup creamy peanut butter
4 cups vanilla ice cream, softened
1 cup heavy cream
½ teaspoon vanilla extract
3 tablespoons powdered sugar
Hot fudge topping
Coarsely chopped salted dryroasted peanuts

Directions

Stir together cereal, finely chopped peanuts, and butter in a medium bowl. Press mixture into bottom and up sides of a lightly greased 9-inch glass pie plate. Freeze until solid, 15 to 30 minutes. Microwave peanut butter in a small microwave-safe bowl on HIGH until melted and smooth, about 30 seconds. Let stand at room temperature 10 minutes, stirring occasionally. Place ice cream in the bowl of a heavy-duty stand mixer; beat on medium-low until smooth, about 30 seconds. Drizzle peanut butter into ice cream, beating on low just until incorporated, about 30 seconds. Spread ice cream mixture into frozen pie shell. Cover and freeze until firm, 8 hours, or up to 24 hours. Before serving, remove pie from freezer, and leave out at room temperature 10 minutes. Meanwhile, beat cream and vanilla with an electric mixer on medium-high speed until foamy, about 30 seconds. Gradually add powdered sugar, beating until soft peaks form, 30 seconds to 1 minute. Spread whipped cream evenly over pie. Drizzle with fudge topping, and sprinkle with coarsely chopped peanuts.

Summer Rates Start June 1st

The summer electric rate schedule for North Central Public Power District (NCPPD) will go into effect on June 1, 2024. These rates are effective for the four summer demand months: June, July, August and September. The whole-sale, as well as retail, electric rates are higher because Nebraska Public Power District (NPPD) charges NCPPD higher wholesale rates due to its higher costs during this time. It is NCPPD's goal to keep the summer electric peak demand down to prevent or lessen rate increases in the future.

NCPPD encourages customers to reduce their electric usage during these months between the hours of 9 a.m. to 11 p.m. If everyone does their part to reduce usage, hopefully electric rates can continue at an affordable level.
